Definitions	
Household	A household consists of all the people who occupy a housing unit. A house, an apartment or other group of rooms, or a single room, is regarded as a housing unit when it is occupied or intended for occupancy as separate living quarters; that is, when the occupants do not live and eat with any other persons in the structure and there is direct access from the outside or through a common hall.
Household head	Beginning with the 1980 CPS, the Bureau of the Census discontinued the use of the terms "head of household" and "head of family." Instead, the terms "householder" and "family householder" are used. The householder refers to the person (or one of the people) in whose name the housing unit is owned or rented (maintained) or, if there is no such person, any adult member, excluding roomers, boarders, or paid employees. If the house is owned or rented jointly by a married couple, the householder may be either the husband or the wife. The person designated as the householder is the "reference person" to whom the relationship of all other household members, if any, is recorded.
Data quality aspects	
Unit response rate	For the cases eligible for the 2005 ASEC, the basic CPS nonresponse rate was 9.4 percent. The nonresponse rate for the Annual and Economic Supplement was an additional 9.4 percent. These two nonresponse rates lead to a combined supplement nonresponse rate of 17.4 percent.
Item non-response /	Missing data are assigned values based on hot-deck imputation.

Weighting	Weights adjust for sample non-response and inflate to total population calibrated in two ways: age, sex and race, and age, sex and Hispanic origin. The ASEC file includes a further adjustment so husband and wife of a household receive the same weight.
